- Alternatives to a garden town at Grazeley are to be considered. A legislative change caused emergency planning requirements around the Atomic Weapons Establishment (AWE) at Burghfield to be extended and they now include the Grazeley area. A High Court judge ruled against a developers consortium challenging the expansion of the emergency planning zone around the AWE. Masterplanners are testing potential sites between Shinfield /Arborfield / Sindlesham and South of Wokingham.
- Mr S Conway stated that there is a threat to our area and non greenbelt land is more vulnerable.
- Planning permission has been granted for Twyford Library.
- Planning application 20-22 Station Road was refused
