Minutes of a meeting of the Parish Lands Committee held at 7.45 pm on Tuesday 11th October 2022 at Loddon Hall, Twyford, RG10 9JA.

- 3. Declaration of interest in items on the agenda. None.
- **4. Minutes dated 12**th **July 2022.** Minutes approved as a true and accurate record. Proposed Mrs E Ashley, seconded Mr M Bray. Motion carried unanimously.
- 5. Matters arising.
 - **5.1** Requirement to plant a tree to replace the Alder that needs to be felled at the Burial Ground noted.
- **6. Sports Clubs (15 minutes)** an opportunity for the sports clubs to raise any requests or ask questions. Mr B Gilbert introduced himself as Chairman of Twyford Comets. He reported on the membership with over 400 members including a steady increase of girls. He expressed interest in the Stanlake Pavilion re-development discussions.

 - Allotment holder paved path. Request to reconsider the request for Mr March
 to lift the path. The request was accompanied with signatures from allotment
 holders supporting the request for the path to remain. As six months had passed
 from the original decision the committee reconsidered the allotment path put
 down by Mr March using paving slabs. The committee gave permission for the
 path to remain, on this occasion, however, they asked that the clerk write to all
 London Road allotment holders stating that although permission has been given
 permission should be sought before allotment holders carry out any further work
 on the communal paths.

 - **9.1** Twyford in Bloom sign to approve the quote £166.40 unanimously approved.

 - **10.1** Dip in block paving where Christmas tree goes possible trip hazard photograph in one drive folder unanimously agreed no action.

 - Mrs Wisdom reported that she is working on a project plan. The clerk suggested that she could seek copies of project plans from other Town / Parish Councils and also suggested contacting Ricky Josey at Wokingham Borough Council for assistance. Agreed no action from the clerk at this stage. Mrs Wisdom will circulate her drafted plan in due course.

 - **11.3** Inspection cover new frame £90 authorised by the clerk using Financial Regulation 3.4 as this was a health and safety danger. Noted.
